

## 2019 University Bookstore and Library Agreement

This statement must be signed by the bookstore official responsible for monitoring the release of secure materials.

**Libraries:** All first-time orders from libraries must be accompanied by a signed statement agreeing to the conditions outlined below. This statement must be signed by the librarian or instructor responsible for monitoring the release of secure materials.
